We request that any and all patents for said inventions be issued to John Spurgeon in the United States and in all countries foreign to the United States, or to such nominees as John Spurgeon may designate.

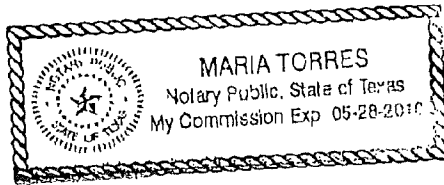

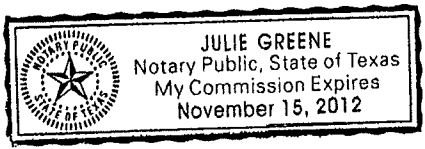
