ASSIGNMENT

WHEREAS, WE, RUSSELL W. ANDERSON, residing at 5 Reservoir Road, Goshen, New York 10924; LAWRENCE C. HANLON, residing at 33 Summerfield Street, Naugatuck, Connecticut 06770; and GORDON F.
