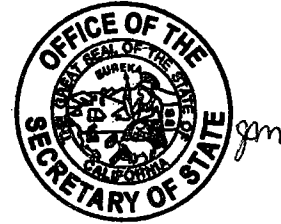

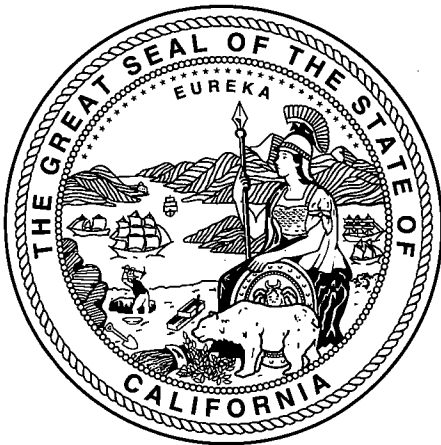

The undersigned certify that:


1. They are the President and an Assistant Secretary, respectively, of Advanced Cardiovascular Systems, Inc., a California corporation.
2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:


The name of the corporation is Abbott Cardiovascular Systems Inc.
