## ASSIGNMENT

The Assignor agrees to perform all affirmative acts which may be necessary to vest all rights therein hereby conveyed to said Assignee as fully and entirely as the same would have been held by the Assignor if this Assignment and sale had not been made.

The Assignor hereby covenants that he has the full right to convey the entire interest herein assigned, and that he has not executed, and will not execute, any agreement in conflict herewith.

The Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment.
