

sign all lawful papers requisite for the filing of such disclaimer, and we further covenant and agree that I will, at any time upon request, do everything legally possible to aid said Corporation, its successors, assigns, nominees or other legal representatives, either in its or their own name, to apply for, obtain and enforce proper patent and/or Utility Model protection for said invention in all countries, all without further consideration but at the expense of said WESTINGHOUSE ELECTRIC COMPANY LLC, its successors, assigns, nominees or other legal representatives.
