AND I hereby authorize and request the Commissioner for Patents of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said invention or any part thereof, to said ASSIGNEE;


AND I hereby jointly and severally agree for myself and for my respective heirs, executors and administrators, to execute
