for such infringement, and now being the same for said Purchaser's own use and for the use of its assigns, successors, and legal representatives to the full end of the term for which said letters patent may be granted, as fully and entirely as the same would have been held and enjoyed by Phillips and its affiliates, as applicable, had this assignment and sale not been made.

And Phillips for itself and its affiliates, and their respective heirs, assigns, and legal representatives hereby further covenants to and with said assignee Purchaser, its assigns, successors, and legal representatives to fully cooperate therewith in perfecting this assignment in the United States and in any and all foreign jurisdictions, said cooperation extending to any United States or foreign divisional, continuing, substitute, renewal, reissue, or any other application derived from the Patents, and including the execution of additional assignments or other formal documents as may be required in connection therewith.

Phillips warrants that the rights and property herein conveyed are free and clear of any encumbrance.
