ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT



NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, conveys, and transfers unto Assignee its entire continuing first priority security interest in all of Grantor's right, title and interest in, to and under the Patent Collateral as specified in the Intellectual Property Security Agreement. This Assignment is expressly made NUNC PRO TUNC to have the same legal force and effect as if executed on September 26, 2008.






