ASSIGNMENT AND ASSUMPTION AGREEMENT

Reference is made to (i) the Amended and Restated Credit Agreement, dated as of August 9, 2007 (the "Credit Agreement"), by and among Syniverse Technologies, Inc. ("Borrower"), the guarantors party thereto ("Guarantors"), the lenders party thereto from time to time, Lehman Commercial Paper, Inc., as administrative agent (in such capacity, the "Administrative Agent"), (ii) the Guarantee and Collateral Agreement (the "Security Agreement"), dated as of February 15, 2005, entered into by and among Borrower, the Guarantors, as pledgors, assignors and debtors, and the Administrative Agent, (iii) the Intellectual Property Security Agreement, dated as of February 15, 2005, entered into by Borrower, in favor of the Administrative Agent (the "Borrower IP Security Agreement"), and (iv) the Intellectual Property Security Agreement, dated as of February 15, 2005, entered into by Syniverse Brience, LLC, in favor of the Administrative Agent (the "Syniverse Brience IP Security Agreement") and, together with the Borrower IP Security Agreement, the "Intellectual Property Security Agreements").

Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Security Agreement, the Intellectual Property Security Agreements or the Assignment (defined below), as applicable.

WHEREAS, pursuant to the Borrower IP Security Agreement, which was recorded with the U.S. Patent and Trademark Office on May 10, 2006 at Reel/Frame No. 3080/0949, Borrower granted the Administrative Agent a security interest in and to all of its right, title and interest in and to the Trademarks listed on Schedule I(A), and the goodwill of the business connected with the use of, and symbolized by, such Trademarks, and any and all proceeds of the foregoing;

WHEREAS, pursuant to the Borrower IP Security Agreement which was recorded with the U.S. Patent and Trademark Office on May 10, 2006 at Reel/Frame No. 0155991/0303, Borrower granted the Administrative Agent a security interest in and to all of its right, title and interest in and to the Patents listed on Schedule I(B), and any and all proceeds of the foregoing;

WHEREAS, pursuant to the Syniverse Brience IP Security Agreement which was recorded with the U.S. Patent and Trademark Office on May 10, 2006 at Reel/Frame No. 3080/0938, Syniverse Brience granted the Administrative Agent a security interest in and to all of its right, title and interest in and to the Trademarks listed on Schedule II(A), and the goodwill of the business connected with the use of, and symbolized by, such Trademarks, and any and all proceeds of the foregoing;

WHEREAS, pursuant to the Syniverse Brience IP Security Agreement which was recorded with the U.S. Patent and Trademark Office on May 10, 2006 at Reel/Frame No. 0155994/0735, Syniverse Brience granted the Administrative Agent a security interest in and to all of its right, title and interest in and to the Patents listed on Schedule II(B), and any and all proceeds of the foregoing;

WHEREAS, on May 4, 2009, the Administrative Agent (in such capacity, the "Resigning Agent") delivered a notice of resignation to the Lenders and the Borrower providing notice of its resignation as Administrative Agent pursuant to and in accordance with Section 9.9 of the Credit Agreement, and in connection therewith, the Lenders appointed Bank of America N.A. as successor Administrative Agent (in such capacity, the "Successor Agent") pursuant to the Assignment and Amendment Agreement, dated as of May 4, 2009 (the "Assignment").

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each of the Resigning Agent and the Successor Agent hereby agree as follows:

The Resigning Agent hereby irrevocably assigns to the Successor Agent without recourse, representation or warranty, and the Successor Agent hereby assumes from the Resigning Agent, the interest in and to the Resigning Agent's rights and obligations under the Intellectual Property Security Agreements (the "Assigned Interest"), as of the Effective Date (as defined below).

The effective date of this Assignment and Assumption Agreement shall be the date of execution by all parties (the "Effective Date"). Following the execution of this Assignment and Assumption Agreement, it will be delivered to the Successor Agent for recording by the Successor Agent pursuant to the Security Agreement and the Intellectual Property Security Agreements with the United States Patent and Trademark Office.

From and after the Effective Date, (a) the Successor Agent shall be a party to the Intellectual Property Security Agreements and shall have the rights and obligations of the Administrative Agent thereunder and under the other Loan Documents and shall be bound by the provisions thereof, and (b) the Resigning Agent shall relinquish its rights and be released from its obligations under the Intellectual Property Security Agreements.




