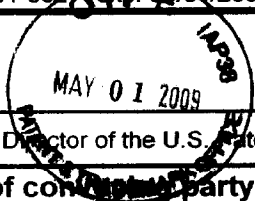


Patent Assignment
