

And I hereby authorize and request the Commissioner of Patents and Trademarks, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the Inventions to Lactillion, Inc., its successors, legal representatives and assigns, as the assignee of the whole right, title and interest thereto;

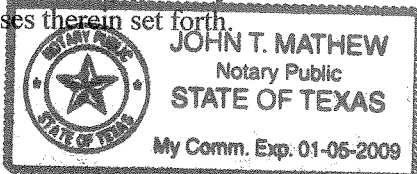
