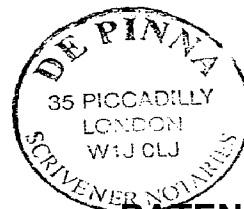


PATENT LICENSE

With respect to Germany and without limiting the foregoing, Licensor expressly approves Licensee's recordation and registration in Germany of Licensee's exclusive license under any German patent(s) issued from or claiming priority from any of the Assigned Patents.
