5. Said Assignor(s) hereby authorize and request the attorneys of record to insert, where indicated above, the application number and filing date of said application when known.

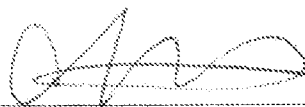

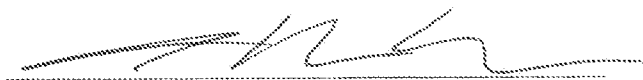
