1. They are the President and the Secretary, respectively, of Solvay Draká, Inc., a California corporation.

2. Article One of the Articles of Incorporation of the Corporation is amended to read as follows:

One: The name of the Corporation shall be American Renolit Corporation LA

3. The foregoing Amendment of Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing Amendment of Articles of Incorporation has been duly approved by the sole stockholder of all of the outstanding shares of all classes of capital stock of the Corporation by unanimous written consent in accordance with Section 902 of the General Corporation Law of California. There were 249,374 outstanding shares of Class A Common Stock and 13,124 shares of Class B Common Stock entitled to vote with respect to the amendment. The number of shares of each class voting in favor of the amendment exceeded the vote required. The affirmative vote of a majority of the outstanding shares of each class of Common Stock was required.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate are true and correct of our own knowledge.
