RELEASE OF SECURITY INTEREST IN LICENSE OF PATENT 5,709,616

WHEREAS, pursuant to a License Agreement entered into by Spalding Sports Worldwide, a division of Spalding & Evenflo Companies, Inc. ("*Spalding*") on July 19, 1996, Spalding was granted a license (the "*License*") to use Patent 5,709,616 (the "*Patent*").

WHEREAS, pursuant to that certain Security Agreement dated March 30, 1998 among Evenflo & Spalding Holdings Corporation ("*Spalding Holdings*"), Spalding, and certain subsidiaries of Spalding (collectively the "*Grantors*"), and Bank of America National Trust & Savings Association ("*BoA*") as administrative agent for the lenders, among other parties, the Grantors granted BoA as administrative agent a security interest in the License to the Patent, as recorded in the Patent Office of the United States Patent and Trademark Office (the "*PTO*") on May 20, 1998 at Reel 009342, Frame 0379, and recorded in the Patent Office of the PTO on May 22, 1998 at Reel 009516, Frame 0369 (collectively, the "*March 20th Security Agreement*").

WHEREAS, pursuant to that certain Security Agreement dated March 31, 1998 among the Grantors and BoA as administrative agent for the lenders, among other parties, the Grantors granted BoA as administrative agent a security interest in the License to the Patent, as recorded in the Patent Office of the PTO on May 22, 1998 at Reel 009227, Frame 0574 (the "*March 31st Security Agreement*", and collectively with the March 30th Security Agreement, the "*Security Agreements*").

WHEREAS, the License has been terminated and Guerin Rife Putters, LLC, the current rightful owner of the Patent, desires that the security interest granted by Grantors to BoA pursuant to the Security Agreements be released, and BoA desires to grant such release.

NOW THEREFORE, Bank of America National Trust & Savings Association does hereby release, exonerate, and discharge the lien, security interest and encumbrance on the Patent and the License to the Patent granted to it pursuant to the above-referenced Security Agreements.

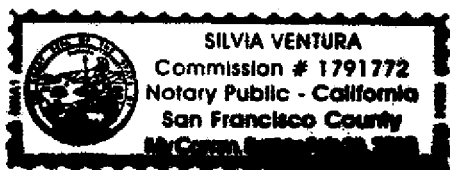
