

4. Pursuant to the attached Exhibit C Assignment dated May 28, 2007, certain assets, including intellectual property, were assigned from Packaged LLC to the Corporation, including U.S. Patent No. 7,074,451 and Appln. Serial Nos. 11/227,640 and 11/451,718.

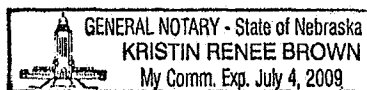

ASSIGNMENT AND ASSUMPTION AGREEMENT

AGREEMENT, dated effective as of November 28, 2004 (the "Effective Date"), between CONAGRA GROCERY PRODUCTS COMPANY, a Delaware corporation ("Assignor"), and CONAGRA FOODS PACKAGED FOODS COMPANY, INC., a Delaware corporation ("Assignee").

For value received, from and after the Effective Date, Assignor hereby assigns and transfers to Assignee, and Assignee hereby assumes and agrees to pay, perform and discharge, (i) all of the liabilities and obligations of Assignor reflected in op units 00573, 00578, 00579, 01898, 02404, 02513, 02515, 02897, 03187, 03233, 03241, 03295, 03296, 03297, 03303, 03306, 03310, 03312, 03313, 03314, 03316, 03317, 03319, 03320, 3322, 03323, 03324, 03325 and 03697 (collectively, the "Op Units"), each as included in the November 28, 2004 balance sheet of Assignor which is attached hereto as Exhibit "A", and (ii) all of Assignor's right, title and interest in and to all currently existing agreements, licenses and permits to which Assignor is a party which principally relate to any of the Op Units or the assets, liabilities or obligations reflected in such Op Units (collectively, the "Assigned Items"). Assignee does not assume and shall not be deemed to have assumed, and shall not be obligated to pay, perform or otherwise discharge, any liability or obligation of Assignor, whether arising by contract, tort, operation of law or otherwise, except as specifically provided in the immediately preceding sentence, and all such liabilities and obligations of Assignor which are not expressly assumed by Assignee hereunder shall remain with Assignor.

If the assignment of any of the Assigned Items by Assignor to Assignee shall require the consent of any party thereto other than Assignor, this Assignment and Assumption Agreement shall not constitute an agreement to assign the same, and such Assigned Item shall not be assigned to or assumed by Assignee if an actual or attempted assignment thereof would constitute a breach or default thereunder. If any such consent is not obtained, Assignor and Assignee will cooperate in any reasonable arrangement designed to obtain for Assignee all benefits and privileges of the applicable Assigned Item.

At and after the Effective Date, the parties hereto shall execute and deliver such additional documents and take such additional actions as may be reasonably necessary or advisable in order to effect the assignment and assumption contemplated by this Assignment and Assumption Agreement.

This Assignment and Assumption Agreement shall be governed by and construed in accordance with the internal laws (as opposed to the conflicts of law provisions or rules) of the State of Delaware.




