Assignor also does hereby covenant without further remuneration, to execute and deliver all documents required for transferring the said Patent Application to said Assignee or its assigns, to sign all lawful papers, make all rightful oaths, and to do everything necessary to aid said Assignee, its successors, assigns and nominees to register the Assignment of the Patent Application, the expenses incidental to said registration to be borne and paid by said Assignee.
