ASSIGNMENT

WHEREAS, Fiona Adams, a citizen of the United Kingdom, residing at Scaddows House, Scaddows Lane, Ticknall, DE73 7JP, Derbyshire, England, hereinafter referred to as ASSIGNOR, has invented a certain design entitled:

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Design Letters Patent as may be known and accessible to ASSIGNOR and ASSIGNOR will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce said application, said design and said Design Letters Patent which may be necessary or desirable to carry out the purposes hereof.
