1 Assignment

For good and valuable consideration, the Assignor hereby assigns to the Assignee, as legal and beneficial owner, all its right, title and interest in and to the Patents and any applications for patents, patents granted thereon or other intellectual property rights arising therefrom, that may be made in Australia or overseas including without limitation:

- (a) the right to sue for any infringement occurring prior to the date of this Deed and the right to recover damages for that infringement;
- (b) the right to apply for restoration of any lapsed or ceased patent applications;
- (c) the right to file national phase applications in relation to international PCT applications, in any PCT contracting state; and
- (d) the right to file international PCT applications or complete applications in relation to pending provisional applications,

but notwithstanding the above, excluding all moral rights, and similar person rights, which by law are non-assignable, and any right to claim (and retain) damages and other remedies in relation to those non-assignable personal rights.

2 Warranty

The Assignor warrants that:

- (i) it owns free from encumbrances all rights in and to the Patents;
and
- (ii) it has all rights required to make this assignment.

3 Further Action

At the request of the other party, each party must do anything at its own expense (including executing agreements and documents) necessary or desirable to give effect to this Deed and the transactions contemplated by it, including, without limitation, enabling the Assignee to become registered as the proprietor of the rights in the Patents.

4 Governing law and jurisdiction

This Deed is governed by the laws applicable in New South Wales and each party submits to the non-exclusive jurisdiction of the courts of New South Wales and waives any right to claim that those courts are an inconvenient forum.
