**AMENDMENT OF
SHORT FORM ASSIGNMENT**

This Amendment to the Short Form Assignment ("Amendment"), amends the Short Form Assignment, dated May 26, 2005, to the Technology Transfer Assignment Agreement ("Transfer Agreement"), dated May 26, 2005, between Capital Strategies Fund, Ltd. ("Capital"), an entity organized and existing under the laws of the British Virgin Islands, and Talisman Capital Talon Fund, Ltd. ("Talisman"), an entity organized and existing under the laws of the British Virgin Islands.

Whereas, pursuant to a Technology Transfer and Assignment Agreement, dated April 23, 2003, between Rudolf W. Gunnerman ("Gunnerman"), as assignor, and Capital, as assignee (hereafter the "Gunnerman Assignment Agreement"), Capital acquired and held certain rights, including the Assigned Assets (as defined in the Gunnerman Assignment Agreement);

Whereas the Gunnerman Assignment Agreement was later amended, said amendment made effective as of April 23, 2003, to assign to Capital Gunnerman's rights under an additional patent application, patent application number 10/659,046, now issued as U.S. patent 7,344,570:

Whereas, pursuant to the Transfer Agreement, Capital assigned all of its rights in the Gunnerman Assigned Assets, including those Patent Rights listed on Schedule A of the Short Form Assignment;

Whereas Schedule A did not include the now issued 7,344,570; patent;

Now therefore, without the necessity of further consideration, the parties hereto agree to amend the Short Form Assignment by adding the 7,344,570 patent to Schedule A of the Short Form Assignment, as follows:

The Parties hereto agree to amend Schedule A to the Short Form Assignment to add U.S. patent number 7,344,570 to Schedule A.


- (1) This Amendment is made effective on May 26, 2005.
- (2) All other terms of the Short Form Assignment remain unchanged.


