## ASSIGNMENT

This Assignment is made the 27<sup>th</sup> day of MARCH 2009

BY AND BETWEEN

E LIGHT LIMITED (hereinafter referred to as "E LIGHT"), a company registered in the Isle of Man whose registered office is at Prospect Chambers, Prospect Hill, Douglas, Isle of Man, IM1 1ET, British Isles of the first part; and

  - 1.3 "Intellectual Property Rights" means collectively the Patents and the Patent Applications.
- 2. In consideration of the sum of £1 (one pound sterling) and other good and valuable consideration, receipt of which is hereby acknowledged, E LIGHT hereby ASSIGNS to HOLDIP with full title guarantee the Intellectual Property Rights together with all E LIGHT's

right title and interest thereto, including the right to file corresponding patent applications in the UK and overseas and to claim priority from any and all of the Intellectual Property Rights.


