ASSIGNMENT

I further agree that we will communicate to said ASSIGNEE or its representatives or agents all facts and information known or available to us respecting said invention or inventions, including evidence for interference purposes or for other legal proceedings, whenever requested; testify in any interference or other legal proceedings; execute and deliver, on request, all lawful papers including original, divisional, continuing and reissue applications, renewals, assignments, power of attorney, oaths, affidavits, depositions, etc., and generally do everything possible to aid said ASSIGNEE, its successors and assigns, but at the expense of ASSIGNEE, in obtaining and enforcing proper protection for said invention or inventions, in the United States and all other countries.


