I hereby warrant and covenant that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others, and that the full right to convey the same as herein expressed is possessed by me/us.

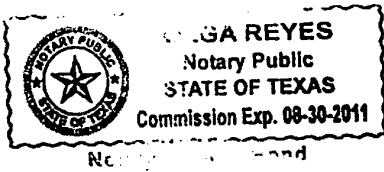
