WHEREAS We, WHEREAS We, 1) Norihiro ISHII, 2) Kengo SASAHARA, 3) Tomoyuki EBIHARA and 4) Kazunari KOGA all of Amagasaki, Hyogo, Japan (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

ELECTRIC GROUND WORKING VEHICLE

which claims priority to **Japanese Application No. 2008-109360**, filed **April 18, 2008**, and for which We are about to file or have filed an application for Letters Patent of the United States;

at the cost and expense of the said ASSIGNEE fully assist and cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.
