
**Assignor** hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale;

Homescape Design, LLC**, its successors, assigns or other legal representatives; and

**Assignor** hereby appoints the Secretary or any other officer of **T.E.S. Homescape Design, LLC**, as **Assignor's** attorney-in-fact and agent to execute all documents required or appropriate to perfect or enforce all rights assigned under this Agreement and further authorizes **Assignor's** attorney and attorneys and the attorney and attorneys for **T.E.S. Homescape Design, LLC**, to register this assignment in any and all countries.

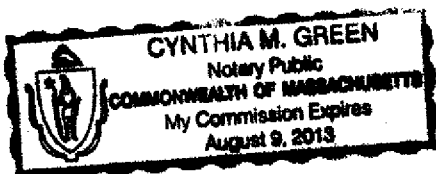
