I will communicate to said Assignee, or its successors any and all facts known to me regarding said invention immediately whenever requested, and will testify in any legal proceeding, sign all lawful papers, provide all tangible property describing or embodying the invention, execute all divisional, reissue, continuation, continuation-in-part, and foreign applications, and generally do everything possible to aid said Assignee, its successors and assigns, to

obtain and enforce proper patent protection for said invention in all countries. I also covenant and agree not to contest the validity or enforceability of any intellectual property rights assigned herein, or to assist or request any third party to contest the validity or enforceability of any intellectual property rights assigned herein.

I do hereby release and forever discharge Assignee for any and all claims, including but not limited to, any debts, liabilities, damages and causes of action of whatsoever kind or nature related to the Invention, whether or not known, suspected, and unsuspected, including any and all previous agreements entered into, which now exist or may have existed prior to the date of this Agreement.

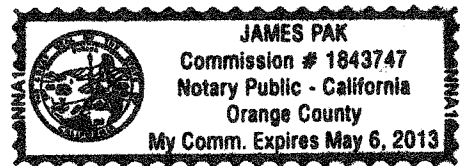
