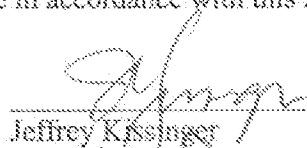
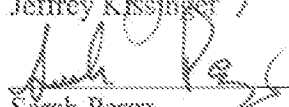
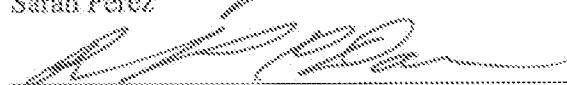
ASSIGNMENT
