ASSIGNMENT AGREEMENT OF INDUSTRIAL PROPERTY RIGHTS

ENTERED INTO BETWEEN:

Jacques GOUGET, a citizen of France, born 19 March 1920, domiciled 3 rue d'Auteuil in Paris (75016),

hereinafter referred to as the "Assignor"

on the one hand,

AND:

Robert GOUGET, a citizen of France, born 6 September 1961, domiciled 3 rue d'Auteuil in Paris (75016), having its activity registered in the Registry under the number 331753442,

hereinafter referred to as the "Assignee",

on the other hand,

Hereinafter individually referred to as "a Party" or jointly as "Parties"

RECITALS:

Whereas the Assignor is the owner of patents, trademarks and designs and models protected by industrial property and listed in Schedule 1 (hereinafter the "Assets");

Whereas the Assignee has continuously and with the full and complete acceptance of the Assignor exploited since January 1st, 1990 in his name and for himself the said Assets and hereby wishes to regularize the assignment to its benefit.

NOW, THE PARTIES AGREE AS FOLLOWS:

Article 1 - Scope of the agreement

The Assignor hereunder irrevocably and exclusively assigns to the Assignee, which accepts, the full ownership of the Assets listed in Schedule 1 as well as of all prerogatives and rights attached to the said Assets.

Article 2 - Assignment

The Assignor hereby assigns to the Assignee, which accepts at his own risks, the full and entire ownership of the Assets as well as the related priority rights.

The agreement carries the firm and definitive assignment, on an exclusive basis, of the industrial property rights and regarding the Designs and Models the copyrights attached to them, for the whole world, irrevocably and without restrictions or limitations of any nature whatsoever for the whole protection period, as fixed by current or future legislation, whether French or foreign, and international conventions, including for the possible extensions of this period.

Regarding Designs and Models, the assigned rights will include in particular:

- (i) the right to reproduce and represent copyrights attached to Models on any medium and for any destination, including archiving or advertising, and for any exploitation mode regarding the right to reproduce or to represent;
- (ii) the right to adapt, to modify or to merge;
- (iii) the right to exploit or to commercialize copyrights attached to the Models.

As a result of the assignment, the Assignee shall, from the Effective Date of the assignment, have the sole and full ownership of the Assets as well as the right to exercise all rights, prerogatives and benefits attached to them.

The Assignor also assigns to the Assignee, who accepts, all rights to initiate legal actions based on counterfeiting which are not barred on the date of the present Agreement and which may have been committed prior to the current Agreement. The possible fees, risks or benefits which may result from counterfeiting acts committed prior to the present Agreement, will exclusively be borne by the Assignee and exclusively benefit him.

As a consequence, the Assignee enters from the Effective Date of the present Agreement into the rights, actions and privileges of the Assignor regarding the Assets, which he will be able to make free use of.

Article 3 - Assignor representations

The Assignor warrants and represents he is the exclusive owner of the Assets and that the Agreement is free of any licence and of any liens, security interests or encumbrances, and is as a consequence able to assign them.

The Assignor undertakes to deliver to the Assignee the official titles of these Assets, as well as all documents which may allow the Assignee to maintain them into force, including in particular:

- (i) the registration certificates for each Patent, Trademark or Designs and Models;
- (ii) the state of annuities;
- (iii) evidence of the status of registrations or ongoing registrations related to each of the Assets.

The Assignor also undertakes to deliver to the Assignee all documents which may be sent to him after the execution of this Agreement.

Finally, The Assignor warrants and represents that the annuities in order to maintain the Assets into force have been paid on a regular basis.

The Assignor does not grant any other warranty than that resulting from his personal acts and of the material existence of these Assets.

Article 4 - Consideration

Article 5 - Effective date of the Assignment

The date on which the assignment Agreement will come into force is the date of the execution of the Agreement by the last of the two parties.

Article 6 - Notice

All powers are granted to the holder of an original copy of the present agreement in order to request or perform all formalities, registration, publication, filing or mention, wherever and in any administration where necessary.

The fees related to the filing of the present will be supported by the Assignee.

The Assignor moreover undertakes to deliver at any time, upon simple request of the Assignee, any documents or signature which may be necessary in order for the Assignee to fully benefit from the ownership of the Assets.

Article 7 - General Terms

7.1. - Entire agreement

The Parties undertake that this Agreement constitutes their full agreement and substitutes itself to any offer, term or prior agreement, whether oral or written.

7.2. - Amendment of the Agreement

No subsequent agreement, no modification of the contract, whatever its form, will be deemed enforceable between the Parties in the absence of an amendment duly dated and signed by them.

7.3. - Nullity

If any term of this Agreement shall be held unenforceable, void or null under a rule of law in force or by a definitive decision of a competent court, such term will be deemed non written and the remainder of this Agreement shall remain in full force and effect.

7.4. - Waiver

The fact for one or the other Party not to lay claim to the enforcement of any clause of the Agreement or to assent to its non performance, whether on a perpetual or a temporary basis, shall not be construed as a waiver by the said Party to the rights arising under the said clause.

7.5. - Domicile

The Parties elect domicile at the addresses mentioned on the first page of this Agreement.

Article 8 - Applicable law and dispute resolution



The present Agreement is governed by the laws of France even in the event that part or all of the assignment should be performed abroad.
