**PARTIAL RELEASE OF SECURITY INTEREST IN PATENTS**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN PATENTS (this "Release") is made as of June 11, 2009 (the "Effective Date") between GENERAL BINDING CORPORATION, a Delaware corporation (the "Pledgor") and CITICORP NORTH AMERICA, INC., as Administrative Agent (in such capacity, the "Administrative Agent").

WHEREAS, pursuant to the terms and conditions of that certain U.S. Patent Security Agreement, dated as of November 15, 2005 between the Pledgor and the Administrative Agent (the "Security Agreement"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Pledgor granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to the patents, including without limitation the patents and patent applications set forth on Schedule I hereto (collectively, the "Patents");

WHEREAS, the Security Agreement was recorded with the U.S. Patent and Trademark Office on August 29, 2005, at Reel 016914 and Frame 0813; and

WHEREAS, in accordance with the terms of the Security Agreement, certain Patents of the Pledgor are to be sold pursuant to that certain Asset Purchase Agreement dated as of January 29, 2009, as amended by the First Amendment to the Asset Purchase Agreement dated June 11, 2009, by and between ACCO Brands Corporation and Cosmo Films Limited (the "Asset Purchase Agreement"), and, in connection therewith, the Pledgor has requested Administrative Agent to release, and Administrative Agent and the Secured Parties have agreed to release, their lien on all Patents identified on Schedule I annexed hereto (the "Released Patents").


NOW, THEREFORE, the Administrative Agent without representation or warranty of any type hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgor pursuant to the Security Agreement in all Released Patents to be sold pursuant to the Asset Purchase Agreement identified on Schedule I annexed hereto, and all liens, security interests, charges or other encumbrances in favor of Administrative Agent in the Released Patents shall hereby terminate and revert to the Pledgor and all right, title and interest of Administrative Agent in the Released Patents will hereby cease, terminate and become void.

Notwithstanding the foregoing release of the Released Patents, the Administrative Agent hereby confirms its lien on and security interest in all right title and interest in and to all other Patents pledged to it under the Security Agreement.
