PATENT ASSIGNMENT

WHEREAS TYCO HEALTHCARE GROUP LP, a Delaware limited partnership (hereinafter "Assignor"), the full address of whose principal office or place of business is 15 Hampshire Street, Mansfield, Massachusetts 02048, is the owner of patents and patent applications that are solely related to the Precision Interconnect Business (as defined below) of PRECISION INTERCONNECT, INC. (hereinafter, "Assignee"), including but not limited to the patents and patent applications identified on the attached Schedule A;

WHEREAS Assignor wishes to assign to Assignee all right, title and interest Assignor has in the Assigned Patents (as defined below);

WHEREAS, Assignor does not wish to assign to Assignee, and is not by this instrument assigning to Assignee, any right, title or interest in the Arbo Patents (as defined below); and

WHEREAS Assignee, a Nevada corporation, the full address of whose principal office or place of business is 10025 SW Freeman Court, Wilsonville, Oregon 97070, is desirous of acquiring the aforementioned rights to said Assigned Patents, and Assignee understands that it is not receiving by this instrument any assignment of the Arbo Patents.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and effective herewith, Assignor agrees as follows:

1. DEFINITIONS.

a. "Arbo Patents" shall mean the patents and patent applications identified on the attached Schedule B, whether or not they are owned by Assignor.

b. "Precision Interconnect Business" shall mean Assignee's business of providing cable assemblies to connect diagnostic and test instrumentation equipment for medical and instrumentation original equipment manufacturers.

c. "Assigned Patents" shall not include the Arbo Patents, but shall mean any and all other patents and patent applications and the inventions disclosed therein, including any and all know-how necessary to practice them, that Assignor owns as of the Effective Date that are solely related to the Precision Interconnect Business, whether or not said patents and patent applications appear on Schedule A.

d. "Effective Date" shall mean the date upon which a duly authorized officer of Assignor executes this Agreement on behalf of Assignor.

2. **ASSIGNMENT.** Assignor does hereby assign, convey, transfer and otherwise set over to Assignee, its successors, and its assigns, all right, title, and interest in and to the Assigned Patents including, but not limited to, all provisionals, divisions, continuations, continuations-in-part, re-examinations, reissues, inventor's certificates, utility models, utility certificates, patents

of importation, registration of patents, design registrations and all renewals and extensions of the foregoing for all countries, jurisdictions, and political entities of the world, to be held and enjoyed by Assignee as fully and entirely as it would have been held and enjoyed by Assignor if this sale and assignment had not been made, including all claims, demands, and rights of recovery that Assignor has or may have in profits and damages for past and future infringements, if any, of said Assigned Patents and all rights to compromise, sue for, and collect such profits and damages and the right to seek and obtain injunctive relief, as well as the right to invoke and claim the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, or under any other convention or law of any country which may be applicable to such Assigned Patents.

3. **CONSENT.** Assignor hereby consents that a copy of this assignment shall be deemed a full and formal equivalent of any assignment, consent to file, or like document, which may be required in any country or region for recordation purposes for any of the foregoing rights conveyed herein.

4. **COVENANTS BY ASSIGNOR.**

a. Assignor and Assignee recognize and acknowledge that Schedule A may contain inaccuracies, including but not limited to (i) the omission of patents that are owned by Assignor and are solely related to the Precision Interconnect Business, or (ii) the inclusion of patents that are not owned by Assignor. Assignor hereby covenants to take any and all actions and execute such documents as are necessary to reflect Assignee's ownership interest in the Assigned Patents, as of the effective date of this Agreement, as conveyed herein.

b. Assignor hereby further covenants that it will, upon Assignee's request, promptly execute and deliver to Assignee or its legal representative any and all papers or instruments required to maintain, enforce or vest title in the Assigned Patents in Assignee or which may be necessary or desirable to carry out the purposes hereof.

c. Assignor hereby further covenants that it will not execute any writing or do any act whatsoever conflicting with these presents.

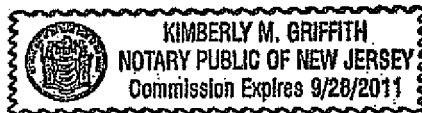

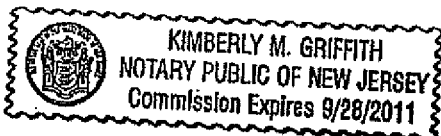
