The right to file foreign patent applications on the subject matter disclosed in the PATENTS in its own name, wherever such right may be legally exercised, including the right to claim the benefits of the International Convention for such applications.

The United States Commissioner of Patents and Trademarks, and other intellectual property officials in this and foreign countries as are duly authorized by their laws to issue patents, are hereby requested and authorized to issue any and all patents and registrations on the subject matter disclosed in the PATENTS to FATPIPE-INDIA as the owner of the entire interest, for the sole use and benefit of FATPIPE-INDIA, its successors, assigns and legal representatives.

This Assignment is effective as of January 13, 2009, or the most recent effectiveness date in conjunction with the merger of FATPIPE-US into FATPIPE-INDIA. This Assignment is also intended to be consistent with and pursuant to the assignment of rights of FATPIPE-US to FATPIPE-INDIA by operation of law, under the January 14, 2009 merger of FATPIPE-US into FATPIPE-INDIA.
