ASSIGNMENT

WHEREAS, We, Baowei Ji, resident of Plano, Collin County, Texas, citizen of China, Kaushik Josiam, resident of Dallas, Dallas County, Texas, citizen of India, and Zhouyue Pi, resident of Richardson, Collin County, Texas, citizen of China, have invented certain new and useful improvements in a "SYSTEM AND METHOD FOR AN EMBS DESIGN TO OPTIMIZE SPECTRUM EFFICIENCY, LINK ADAPTATION AND EMBS TRAFFIC SECURITY" disclosed in an application for United States Letters Patent (Application No. _____, filed _____), said application having been executed concurrently herewith;



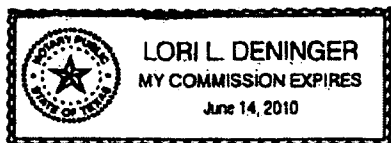
