

Assignment of Invention

WHEREAS WE, **Julien GATINEAU** and **Christian DUSSARRAT**, respectively, have invented certain new and useful improvements in **New Heteroleptic Iridium Precursors To Be Used For The Deposition Of Iridium-Containing Films**, for which a non-provisional application was filed on **April 15, 2009**, having application number **12/424,265**;
