**WAGERING GAME WITH BONUS GAME HAVING
ENHANCED PLAYER-SELECTION FEATURE**

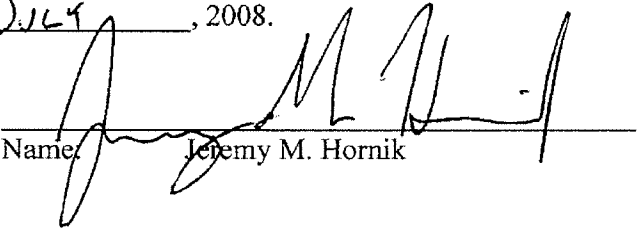

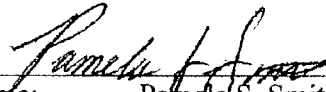
