assigns, Our entire right, title and interest in and to said invention as set forth in the above-mentioned applications, including--the right of priority and including any continuations, continuations-in-part, divisions, reissues, re-examinations or extensions thereof, and in and to any and all patents of the United States and foreign countries that may be issued for said inventions;

UPON SAID CONSIDERATION, We hereby agree with Illumina, Inc. that We will not execute any writing or do any act whatsoever conflicting with these presents, and that We will, at any time upon request, without further or additional consideration; but at the expense of Illumina, Inc., execute such additional assignments and other writings and do such additional acts as Illumina, Inc. may deem necessary or desirable to perfect Illumina's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuations, continuations-in-part, reexamined, reissued, or extended Letters Patent of the United States or of any and all foreign countries on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of assignors and Illumina, Inc.;

AND We request the Commissioner for Patents to issue any Letters Patent of the United States that may be issued for said inventions to Illumina, Inc., its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patent and the invention covered thereby.
