ASSIGNMENT

WHEREAS, I, Tony Eccleston, of city of Newcastle-Upon-Tyne, United Kingdom, have invented a certain invention, entitled TESTING AND VENTING PIPE ANNULUS, described and claimed in U.S. Application No. 12/447,643, filed April 28, 2009, which is a U.S. national stage application of PCT Application No. PCT/GB2007/003778, filed October 5, 2007, which claims priority to Great Britain Application No. GB0621543.8, filed October 30, 2006 (all three of which applications are collectively referred to herein as the "patent applications"); and

will communicate to Wellstream, or its successors and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid Wellstream, its successors and assigns to obtain and enforce proper patent protection for said invention in this or any foreign country. I hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.
