2. Further Assurances. Without additional consideration from the Assignor or additional expense to the Assignor, the Assignee will take such further actions and execute promptly such further documents and instruments as are necessary to effect and record the above assignment, including any actions, documents or instruments required by the applicable registrar to document the transfer herein or as may be necessary to protect, perfect, secure and vest good, valid and marketable title to the Patents and related rights in Assignee.

3. Recording of Assignment. Assignor hereby authorizes and requests the Commission of Patents and Trademarks of the United States, and any officer of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence of forms of intellectual property protection or applications, to issue the

same to Assignee and Assignee's successors, assigns and other legal representatives in accordance with the terms of this instrument. All expenses incurred in connection with the recordation of this Agreement shall be borne solely and exclusively by Assignee.

4. Miscellaneous. This Assignment may be executed in counterparts by one or more parties. All such counterparts, when so executed, shall be deemed to constitute one final agreement as if one document had been signed by all parties to this Assignment. Each such counterpart, upon execution and delivery of all counterparts, shall be deemed to be a complete and original of this Assignment. 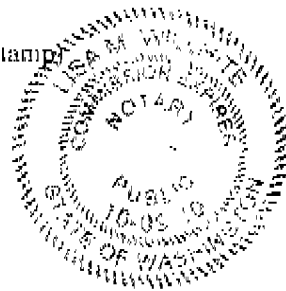
