ASSIGNMENT

WHEREAS, I, PATRICIA URQUIOLA, residing at Via G. Uberti 33, 20133 Milan, Italy, have invented a new original and ornamental design for a SHOWER UNIT for which I have made application for Letters Patent of the United States of America; and


WHEREAS, HANSGROHE AG, a German corporation, having its office and a principal place of business in the City of Schiltach, Country of Germany, desires to acquire the entire right, title and interest in and to said invention;

FOR SAID CONSIDERATIONS, I hereby covenant and agree that I am the owner of the full title herein assigned and have the right to assign the same, and agree that I will communicate to said corporation or its representatives, any facts known to me respecting said invention or inventions and testify in any legal proceedings relating thereto when

called upon, and will sign all instruments and documents and render such assistance which in the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned.
