CONFIRMATION OF ASSIGNMENT

WHEREAS, Koala Corporation, a Colorado corporation, was the owner of patents and patent applications referred to herein and in the annexed Exhibit A; and

WHEREAS, Koala Corporation was a party to a bankruptcy action, Case No. 07-12690ABC in the United States Bankruptcy Court for the District of Colorado, which case was jointly administered with bankruptcy actions for KoalaPlay Group, Inc. (a Colorado corporation), and SCS Interactive, Inc. (an Oregon corporation); and

WHEREAS, the estates of Koala Corporation, KoalaPlay Group, Inc., and SCS Interactive, Inc., were consolidated in said bankruptcy action (following consolidation, the joint estates were sometimes thereafter referred to as "Consolidated Koala"); and


WHEREAS, a plan of reorganization was submitted in said bankruptcy action, and said plan was confirmed by an Order dated August 28, 2007, which Order confirmed the sale of assets including the assets listed in and resulting from the patents and patent applications listed in the annexed Exhibit A, to 07-12690, Inc., a Colorado corporation having an address of 12000 East 47th Avenue, Suite 400, Denver, Colorado 80239; and

WHEREAS, at the time of said Order Bryan F. Merritt was the chief executive officer of Koala Corporation, and the chief operating officer of KoalaPlay Group, Inc., and SCS Interactive, Inc., and pursuant to said Order was and is the Plan Agent authorized to take or cause to be taken all actions that may be necessary to implement and effectuate the provisions of the plan of reorganization including, without limitation, the execution and delivery of all documents necessary to effectuate the transfer of the patents and patent applications listed in the annexed Exhibit A to 07-12690, Inc.; and

WHEREAS, the parties want to confirm the transfer of the patents and patent applications listed in the annexed Exhibit A to 07-12690, Inc., and record notice of the transfer in the U.S. Patent and Trademark Office;

NOW, THEREFORE, for sufficient, good, and valuable consideration, the receipt of which is hereby acknowledged, Koala Corporation (also known as Consolidated Koala, as noted above) and Bryan F. Merritt, in his capacity as the authorized agent of Koala Corporation, and as the authorized Plan Agent under the Order of the Bankruptcy Court, does hereby confirm the assignment and transfer unto 07-12690, Inc., of the entire right and title to and interest in the patents and patent applications listed in the annexed Exhibit A and all inventions described therein, including the right to apply for U.S., international, or foreign patents thereon and the right to sue and collect damage for any infringement of the patents whether occurring in the past or in the future.


