

WHEREAS, I, ANTOINE CARPENTIER, a citizen of FRANCE (hereinafter referred to as "ASSIGNOR"), have invented a patent law office for which application for Letters Patent of the United States of America entitled **USE OF STABILISED OLIGONUCLEOTIDES FOR PREPARING A MEDICAMENT WITH ANTITUMOR ACTIVITY**, which was filed on September 28, 2001 as United States Patent Application Serial No. 09/967,881; and

WHEREAS, **ASSISTANCE PUBLIQUE-HOPITAUX DE PARIS**, a national institute organized and existing under and by virtue of the laws of the Country of **France** and having its principal place of business at **3 avenue Victoria, F-75004, Paris, FRANCE** and **INSTITUT NATIONAL DE LA SANTE ET DE LA RECHERCHE MEDICALE**, a national institute organized and existing under and by virtue of the laws of the Country of **France** and having its principal place of business at **101 rue de Tolbiac, F-75654 Paris Cedex 13 FRANCE** (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the exclusive right, title and interest in, to and under said invention and in, to and under any Patent or similar legal protection to be obtained therefor in the United States of America, its territorial possessions and in any and all countries foreign thereto.


