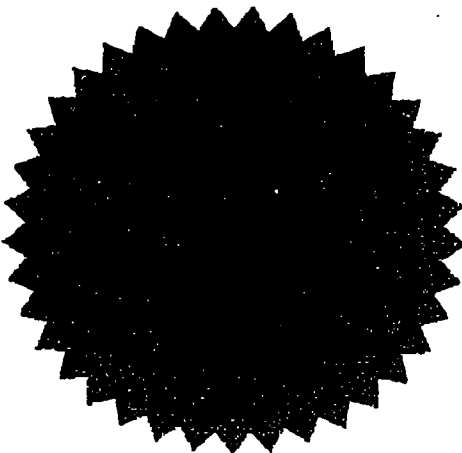

1. They are the Chief Executive Officer and Secretary, respectively, of Dialpad.com, Inc., a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:

**"ARTICLE I**

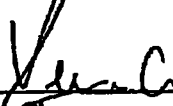
The name of this corporation is Dialpad Communications, Inc."

3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of the corporation.
4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Sections 902 and 903 of the California Corporations Code and the Amended and Restated Articles of Incorporation. The total numbers of shares entitled to vote were 15,629,882 shares of Common Stock and 14,350,841 shares of Preferred Stock, consisting of 7,226,844 shares of Series A Preferred Stock and 7,123,997 shares of Series B Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote was more than 50% of the outstanding shares of Common Stock, more than 50% of the outstanding shares of Preferred Stock, more than 50% of the outstanding shares of Series A Preferred Stock, more than 50% of the outstanding shares of Series B Preferred Stock and more than 50% of the aggregate outstanding shares of Common Stock and Preferred Stock.
