CI LLC further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in CTC, its successors, assigns, and legal representatives.

CI LLC further agrees that it will communicate to CTC, or to its successors, assigns, and legal representatives, any facts known to CI LLC respecting any improvements; and, at the expense of CTC, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in CTC and to aid CTC, its successors, assigns, and legal representatives to obtain and enforce proper protection for the Invention in all countries.

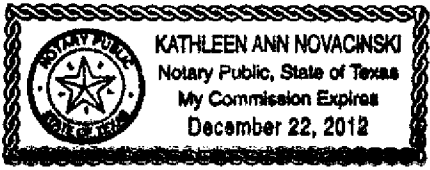
