## ACKNOWLEDGMENT OF REVERSION OF PATENT ASSIGNMENTS

This Acknowledgment of Reversion of Patent Assignments is made this 30 day of June, 2009 in Tampa, Florida.

THOMAS H. HEBERT ("Hebert") is an inventor who assigned his patent rights in various U.S. patents to Global Energy Group, Inc. ("GEG") subject to certain conditions, including the payment of minimum royalties. The assignments were recorded in the United States Patent and Trademark Office. The patent rights subsequently reverted back to Hebert upon his lawful termination of the assignments effective October 15, 2006.

HEBERT previously assigned the Patent Rights to GEG pursuant to Assignment and Agreement documents that were recorded in the Recordation Division of the United States Patent and Trademark Office (the "GEG Assignments.") The GEG Assignments were recorded and can be identified by the reel/frame numbers set forth in paragraph 1.
4. Subsequent to the recordation of the GEG Assignments, HEBERT effected legally sufficient termination of the GEG Assignments in accordance with the termination provisions of the GEG Assignments which termination was effective as of October 15, 2006.
5. Upon HEBERT's termination of the GEG Assignments, the Patent Rights reverted to HEBERT pursuant to paragraph 8.5 of the GEG Assignments.
6. HEBERT therefore now possesses and owns and has possessed and owned the Patent Rights since October 15, 2006.
7. GEG acknowledges that it has not owned or possessed the Patent Rights since October 14, 2006, and acknowledges that it has no claim to the Patent Rights after that date.
8. GEG acknowledges its obligation to timely execute any other documents necessary to demonstrate clear title to the Patent Rights in HEBERT without further consideration owed by HEBERT.
9. A failure by any party to assert any rights under any provision herein shall not be deemed as a waiver of any rights under this Acknowledgement.
10. No changes, modifications, or amendments to this Acknowledgement shall be binding or effective unless in writing, and executed by both parties.
11. This Acknowledgment is governed by and shall be construed and interpreted in accordance with the laws of the State of Florida. Any action or proceeding that may be brought in connection with this Acknowledgement shall be brought in the United States District Court for the Middle District of Florida, Tampa division, and GEG consents to, and shall not oppose for any reason, such jurisdiction and venue.
