Effective 1 May 2007

**THIS AGREEMENT** is effective from 1 May 2007

**BETWEEN:**

- (1) **TANDBERG TELEVISION ASA** a corporation organised under the laws of Norway, whose registered office is at P.O.Box 6643 Etterstad, 0607 Oslo, Fyrstikkalleen 3, 0601 Oslo, Norway (the "Assignor"), and
- (2) **ERICSSON AB** (organisation number 556056-6258) whose registered office is at Torshamnsgaten 23, SE-164 80 Stockholm Sweden (the "Assignee")

**WHEREAS:**

- (A) The Assignor is the registered owner of the patent applications and patents listed in the attached Schedule (the "Patents")
- (B) The Assignor wishes to confirm the assignment of the Patents to the Assignee on the terms of this Agreement

**IT IS AGREED AS FOLLOWS:**

1. 
