ASSIGNMENT

1. Covidien AG, a Swiss Corporation with offices located at Victor von Bruns-Strasse 19, 8212 Neuhausen am Rheinfall, Switzerland (hereinafter "Assignor"), has acquired rights in new and useful improvements in a PUMP SET WITH SECURE LOADING FEATURES and in a United States patent application on the PUMP SET WITH SECURE LOADING FEATURES which is identified below; and

5. Assignor hereby agrees to execute, without further consideration, any further documents deemed necessary by Assignee to fully secure its interest in the Patent Property.
6. Assignor covenants that Assignor has granted no right, or license to make, use or sell the Patent Property to anyone except Assignee; Assignor's right, title and interest in the

Patent Property has not been previously encumbered; and Assignor has not executed and will not execute any instrument in conflict herewith.

7. The United States patent application is serial number 11/366,225 and was filed on March 2, 2006, and identifies Joel D. Wiesner, Christopher A. Knauper, James M. Harr, James G. Hanlon, Joseph A. Hudson, Ricky A. Sisk, Robert B. Gaines, and Kevin C. Meier as the inventors, and is entitled PUMP SET WITH SECURE LOADING FEATURES.
