
ASSIGNMENT

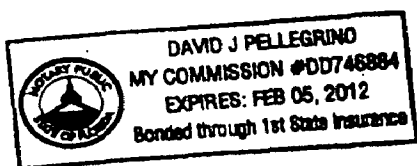


