

litigation when requested, without further compensation but at the expense of said Assignee, its successors or other legal representatives.

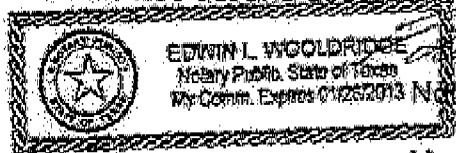

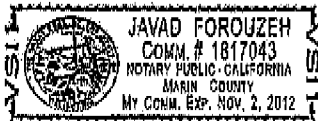
