THE Assignor hereby further agrees, undertakes and covenants that they will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by the Assignee or their legal representatives for the purpose of obtaining or issuing any registrations or Letters Patent for the industrial designs or design patent or any re-
