## JOINT TO CORPORATE ASSIGNMENT

### SELECTIVE REPORTING OF UPSTREAM TRANSACTION TRACE DATA

and have executed a declaration for an application for a United States Patent disclosing and identifying the invention, the declaration being executed on July 7, 9 and 15, 2009.

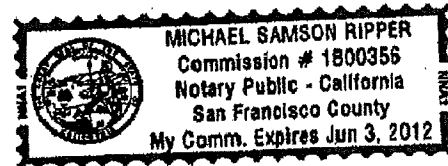

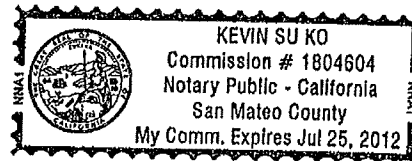

