ASSIGNMENT

WHEREAS, I, Xaver Stemmer, a citizen of the Federal Republic of Germany, residing at Hölderlinstr. 18, 85084 Reichertshofen, Federal Republic of Germany, have made a certain invention entitled **CLAMPING FLANGE ARRANGEMENT FOR CONNECTING AN EXHAUST SYSTEM TO AN INTERNAL COMBUSTION ENGINE** for which I am about to make application for letters patent of the United States of America; and

which said letters patents may be granted, as fully and entirely as the same would have been held by me had this assignment and sale not been made.

For the same consideration, I hereby covenant and agree that I will and that my legal representatives shall execute and deliver any and all application papers, assignments, powers of attorney and other instruments that said Audi AG, may consider necessary or advisable to secure letters patents of the United States of America for said invention, and any continuations, continuations-in-part, divisions, reissues, extensions and renewals thereof, and to vest and confirm in said Audi AG, the full and complete legal and equitable title to said invention, application and letters patents, without further consideration than that now paid but at the expense of said Audi AG.
